

## Visitor Credential Terms and Conditions

By using the Credential and entering Rogers Place or any other area granted access by the Credential (“Facility”), the holder (“Holder”) agrees to be bound by all of the terms of this license as outlined on these Visitor Credential Terms and Conditions given to the Holder along with the Credential, which can also be found at [www.rogersplace.com/accreditation](http://www.rogersplace.com/accreditation). Failure to comply with laws or Facility and other applicable rules may result in refusal of admission or expulsion.

The Credential is issued by OEG for the sole purpose of providing access to an individual in connection with the event for which the Credential is issued (the “Event”). It is issued subject to the following conditions:

Holder assumes all risks incidental to the Event, in connection with the Event, whether occurring prior to, during or subsequent to the Event, including specifically (but not exclusively) the risk of injury by objects including but not limited to hockey sticks, pucks and other equipment. WARNING! DESPITE ENHANCED SPECTATOR SHIELDING MEASURES, PUCKS AND OTHER EQUIPMENT STILL MAY FLY INTO THE SPECTATOR AREA. SERIOUS INJURY CAN OCCUR. STAY ALERT AT ALL TIMES INCLUDING DURING PERFORMANCE, WARMUP AND AFTER PLAY STOPS. IF STRUCK, IMMEDIATELY ASK USHER FOR DIRECTIONS TO MEDICAL STATION.

Any unauthorized transmission, picture, or other depiction or description of Event action, Event information, player/artist interview or other Facility activity is prohibited without prior written approval of Facility, OEG, league, organizer/promoter of the Event or NHL (as defined below).

Holder agrees that Facility, OEG, league, teams, organizer/promoter of the Event and National Hockey League and its constituent clubs and players, including Event participants, NHL Enterprises, L.P. (collectively “NHL”), and their respective agents, representatives, affiliates, officers, directors and employees, are not liable for injuries suffered by Holder whether resulting from such causes or otherwise. In consideration of benefits received, Holder hereby releases Facility, OEG, league, teams, organizer/promoter of the Event and NHL from any liability arising from, and agrees not to assert any claim on account of, Event, including Holder’s presence thereat. Holder shall indemnify, defend (if requested) and hold harmless Facility, OEG, league, teams, organizer/promoter of the Event and NHL from any liability, loss, damage or expense caused by Holder.

Credential is for use solely in connection with Holder’s attendance at the Event at the invitation of Facility, OEG, league, teams, organizer/promoter of the Event or NHL. While within the Facility, Holder shall be subject to direction of OEG.

Credential is not transferable, may be revoked at any time at the sole discretion of OEG, and will automatically terminate if any term is breached.
