

Rogers Place Oil Kings Media/Photo Credential Terms and Conditions

By using the Credential and entering Rogers Place or any other area to which the Credential provides access ("Facility"), Accredited Organization together with holder of the Credential and each of their agents and personnel (collectively, "Holder") agrees to be bound by these Rogers Place Oil Kings Media/Photo Credential Terms and Conditions given to the Holder with the Credential and available at www.rogersplace.com/accreditation. Failure to comply with all applicable laws, regulations, guidelines, and Facility rules (collectively "Rules") may result in refusal of admission or expulsion.

The Credential is issued by Oilers Entertainment Group Canada Corp. ("OEG") for the sole purpose of providing access to an individual with a legitimate working function on behalf of Accredited Organization in connection with the event for which Credential is issued (the "Event"). It is issued subject to the following conditions:

Holder, by acceptance and use of the Credential, each represent and agree that Holder has a legitimate working function at the Event. The Credential is for use solely in connection with Holder news and editorial Event coverage. Non-editorial, commercial or other unauthorized use of any transmission, picture or other depiction or description of Event action, Event information, player/artist interview or other Facility activity, and non-editorial or commercial use of any OEG, WHL mark or WHL club mark is prohibited without prior written approval of OEG or WHL (collectively "Unauthorized Use").

The use of any photographs taken under the Credential shall be strictly editorial and non-commercial and shall be limited to newspapers and news or sporting news periodicals and their respective editorial web sites. Use of photographs without necessary third-party consents shall be Unauthorized Use.

Holder assumes all risks incidental to (i) the performance of his/her service and (ii) the Event, in connection with the Event, whether occurring prior to, during or subsequent to the Event, including specifically, but not exclusively the risk of injury by objects including but not limited to hockey sticks, pucks and other equipment. WARNING! DESPITE ENHANCED SPECTATOR SHIELDING MEASURES, PUCKS AND OTHER EQUIPMENT STILL MAY FLY INTO THE SPECTATOR AREA. SERIOUS INJURY CAN OCCUR. STAY ALERT AT ALL TIMES INCLUDING DURING PERFORMANCE, WARMUP AND AFTER PLAY STOPS. IF STRUCK, IMMEDIATELY ASK USHER FOR DIRECTIONS TO MEDICAL STATION.

Holder agrees that Facility, OEG, Edmonton Major Junior Hockey Corporation, league, teams, organizer/promoter of the Event, Event participants, and their respective agents, representatives, affiliates, officers, directors and employees (the "Releasees") are not liable for injuries suffered by Holder whether resulting from such causes or otherwise. In consideration of benefits received, Holder hereby releases Releasees from any liability arising from, and agrees not to assert any claim on account of, Event, including Holder's presence thereat. Holder shall indemnify, defend (if requested) and hold harmless Releasees from any liability, loss, damage or expense caused by or resulting from Unauthorized Use; Holder; the presence of equipment brought or used by Holder; or the use of depictions or descriptions of matter other than the Event. While within the Facility, Holder shall be subject to direction of OEG.

Credential is not transferable, may be revoked at any time at the sole discretion of OEG, and will automatically terminate if any term is breached.
